January 21 - Pathways PA

Topic: "Giving Sight to the Blind"

Carol Goertzel will discuss how Pathways PA will help us to see the invisible poor around us who need a boost to move to self-sufficiency and higher self-esteem.

Carol Goertzel, President and CEO of Pathways PA, has championed economic self-sufficiency and family well-being for over 30 years. Ms. Goertzel has a MS in Non-Profit Management from Eastern University, a BA in Sociology and Anthropology from Washington University, and has done graduate work in Chinese History at the University of Pennsylvania. Ms. Goertzel recently received the Woman of Distinction Awarded from the Philadelphia Business Journal, DelCo Chamber Award in 2004, "Woman of the Year" of Interboro BPW, and numerous additional awards in recognition of her service to the community. She is a member of the Pennsylvania Commission for Women, the Delaware County Women's Commission, President of the Friends of Delaware County Women's Commission, a trustee of The Center Foundation, and VP of Interboro Business and Professional Women.
