### Time To Give Thanks



The Pilgrims, who celebrated the first thanksgiving in America, were fleeing religious persecution in their native England. On Sept. 6, 1620 the Pilgrims set sail for the New World on a ship called the Mayflower. Aboard were 44 Pilgrims, who called themselves the "Saints", and 66 others, whom the Pilgrims called the "Strangers."

The first winter was devastating to the Pilgrims. The cold, snow and sleet was exceptionally heavy. March brought warmer weather and the health of the Pilgrims improved, but many had died during the long winter. Of the 110 Pilgrims and crew who left England, less than 50 survived the first winter.

The harvest of the following October was very successful and the Pilgrims found themselves with enough food to put away for the winter. The Pilgrims had much to celebrate, they had built homes in the wilderness, they had raised enough crops to keep them alive during the long coming winter, they were at peace with their Indian neighbors. They had beaten the odds and it was time to celebrate.

The Pilgrim Governor, William Bradford, proclaimed a day of thanksgiving to be shared by all the colonists and the neighboring Native Americans. They invited Chief Massasoit and his braves to the celebration which lasted for 3 days. They played games, ran races, marched and played drums. The Indians demonstrated their skills with the bow and arrow and the Pilgrims demonstrated their musket skills.

The custom of an annually celebrated Thanksgiving, held after the harvest, continued through the years. In 1863 President Abraham Lincoln established a national day of thanksgiving, traditionally celebrated on the 4<sup>th</sup> Thursday of November.



**Marc J. Manfre, Director  
Delaware County Parks & Recreation

Director Marc J. Manfre gave the club an overview of the daily operation of 621 acres of county-owned parkland. He focuses on constantly upgrading and improving existing recreational programs along with facilitating new ideas for the enjoyment of future generations.

There are 11 parks in the system, but two earned special recognition by Mr. Manfre in describing their attributes:

**Smedley Park**, which is located on 120 acres of land between Media and Springfield. It attracts many outdoor enthusiasts, scout groups, and local sports teams. It is a multi-purpose recreational area while still maintaining all of its natural beauty. The grounds feature shaded picnic groves, safety-conscious play areas for children, hiking paths, walking bridges over Crum Creek, and playing fields for baseball, softball, soccer and lacrosse.

**Rose Tree Park**, which is located on 120 acres in Upper Providence Township. The picturesque park features grassy rolling hills, mature trees, woodlands, a charming gazebo, picnic areas, and a retired steeplechase. The park is a popular destination for cross country meets, kite flying, photography, poetry readings, dog shows, arts and crafts shows, and various charitable events.



**Detective Lisa Carroll ~ Delaware County  
Internet Crimes Against Children Task Force**

Detective Carroll has a very interesting job which she has practiced for over eight years. During this time, she has received over 500 hours of training in the field of child physical and sexual abuse.

Detective Carroll has worked in an undercover capacity in the area of child pornography and child exploitation where she would engage in online communications with suspects who are looking to engage in sexual contact with a child, or someone who is trying to procure child pornography via any of the communications methods available today.

Detective Carroll is involved in ongoing Public Awareness efforts aimed at Cyber Bullying, a social issue which seems to have grown in recent years with alarming and sometimes tragic consequences. She speaks on this topic to a variety of community groups such as: Students, parent groups such as PTAs, and community groups such as Rotary.

Detective Carroll is a member of the Institute for the Advancement of Women in Law Enforcement.

 Sheriff McGinn came well-prepared for his talk to the group. Many people are unaware of all the responsibilities that come under the umbrella of the office of Sheriff. For example, his office is responsible for the security of the courts, service of civil writs, along with criminal and domestic bench warrants. In addition, Sheriff's Deputies provide transportation

for prisoners to and from the Court House in Media, the county prison and other facilities, as necessary. The Sheriff's office also issues licenses to carry firearms, conducts sales of real estate and personal property as mandated by the courts, teaches D.A.R.E. classes, as well as participates in many community events throughout the county. The Sheriff frequently gives lectures such as the one we enjoyed to civic groups throughout the county.

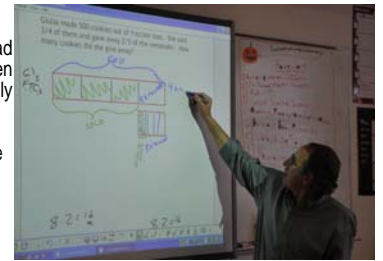

Amen.

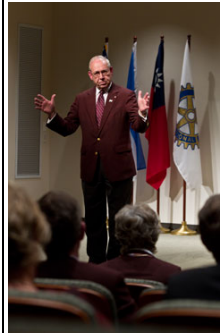

I was a Rotary Scholar at the University of Cape Town in 1961. During my year there, I traveled 16,000 miles through South Africa and the countries now known as Zimbabwe, Zambia, and Namibia. I visited 35 Rotary clubs, met countless Rotarians, and became immersed in the rich culture of Southern Africa.



I developed a deep appreciation for both the traditions and the challenges of life in Africa, and my respect and admiration for the land and people have caused me to return several times as a Rotarian. Now - almost amazingly - I have a unique opportunity to use my experience as a Rotary Scholar to enhance the role of Rotary in Africa!

This is the fourth year of the Reach Out to Africa (ROTA) initiative in an attempt to increase the number of Rotarians in Africa!
